The bid security shall be valid for 30 days beyond the validity period of the bid.
7. Bidders are strictly instructed to submit their bid through only one medium i.e. either through e-bidding or Hardcopy. Sealed or electronic bid must be delivered by hand or courier or through PPMO E-GP System: www.bolpatra.gov.np/egp on or before 13th Sept, 2018 on or before 12:00 (noon) at office of Ministry of Land Management, Agriculture and Cooperative, Province-5, Butwal, Nepal. Bids received after this deadline will be rejected.

Bids will be opened at 12:30 pm on 13th Sept, 2018, in the presence of bidders or their authorized representatives who wish to attend at office of Ministry of Land Management, Agriculture and Cooperative, Province-5, Butwal, Nepal. Absence of bidder's representative in bid opening shall not obstruct the bid opening.
9. If the last date of the Bid purchasing, submission and opening falls on a public holiday, the next working day shall be considered as the last date. In such case the bid validity and bid security validity shall remain the same as specified for the original last date of bid submission.
